

Strengthening the global evidence ecosystem



Vision and mission

Healthcare Information For All (HIFA) is a global human-rights-based campaign that is committed to reduce avoidable death and suffering by promoting 'a world where every person has access to reliable healthcare information and is protected from misinformation'. HIFA's unique mission is to bring together all stakeholders to accelerate progress towards universal access to reliable healthcare information, a prerequisite for Universal Health Coverage and the Sustainable Development Goals, in a spirit of solidarity and co-development.

The challenge


Failure to access and apply reliable healthcare information is a leading cause of preventable death and suffering worldwide. Basic life-saving interventions are very often locally available, but not provided in time because of poor access to reliable information. Everybody needs reliable healthcare information to prevent and manage disease: families and caregivers, health workers, communications and media professionals, public health professionals and policymakers. Everyone has unmet healthcare information needs, which are highly contextual and change from moment to moment. These needs are especially pronounced in low- and middle-income countries (LMICs), in primary healthcare settings and among those who are marginalised.

Rationale and approach

A 2004 paper in *The Lancet* by Fiona Godlee, Neil Pakenham-Walsh and others argued that lack of reliable healthcare information is due to a dysfunctional global evidence ecosystem. The paper proposed a new global initiative to address three fundamental weaknesses: poor communication across the system; poor understanding of drivers and barriers in the system; and poor advocacy for healthcare information as a neglected global health challenge.

HIFA was subsequently launched in 2006.

- HIFA is administered by Global Healthcare Information Network in official relations with WHO
- HIFA has three pillars: Forums, Projects, Advocacy, whose purpose is to strengthen communication, understanding and advocacy across the global evidence ecosystem
- Projects support HIFA's 20,000 members to develop a collective understanding of priority topics
- Partners provide financial and/or technical support

20 years of steady growth


Since its launch in October 2006, HIFA has grown to include more than 20,000 professional members from 180 countries representing every part of the global evidence ecosystem, including health professionals, patients, the general public, policymakers, researchers, publishers, systematic reviewers, guideline developers, producers of reference and learning materials, journalists, social scientists, library and information professionals... HIFA members share experience and expertise around how to improve the availability and use of reliable healthcare information on five global forums in four languages (English, French, Portuguese and Spanish). They represent thousands of organisations around the world, of which more than 400 have officially endorsed the HIFA vision.

Official relations with the World Health Organization

In January 2022 Global Healthcare Information Network, the non-government organisation that administers HIFA, was admitted into official relations status with WHO. The partnership is guided by a <u>Collaboration Plan 2025-2027</u>. The plan has 5 priority areas:

- 1. Recommend next steps for WHO to achieve universal access to reliable healthcare information
- 2. Promote understanding of information needs of the public, health workers and policymakers
- 3. Promote the availability of reliable healthcare information in languages other than English
- 4. Promote the availability and use of WHO publications
- 5. Support WHO's communication and advocacy activities.

Now more than ever HIFA has the opportunity to accelerate progress towards the HIFA vision, building on:


- 1. Our cumulative history of achievements (above)


HIFA Theory of Change

How HIFA accelerates progress towards universal access to reliable healthcare information



Universal access to reliable healthcare information is a prerequisite for universal health coverage and high-level health goals

Progressive realisation of the HIFA vision contributes to meeting the basic (SEISMIC) needs of healthcare providers empowering them to provide quality preventive and healthcare services, strengthening health systems.



Throughout, HIFA will **measure and evaluate value creation** using quantitative and qualitative indicators, including value for individual HIFA members, for HIFA volunteers and

for participating organisations. Methods of evaluation will include statistics regarding members and forum messages, surveys, interviews and testimonials.

Conclusion

HIFA's purpose is to strengthen the global evidence ecosystem by promoting communication, understanding and advocacy. We cannot do this alone and this is why we are working in official relations with WHO; why we have successfully advocated for official policy statements from the world's doctors and the world's library and information professionals; why we have secured official endorsements from more than 400 supporting organisations; and why we bring together more than 20,000 members from 180 countries.

Our first priority is to persuade WHO to explicitly champion universal access to reliable healthcare information and convene stakeholders to develop a global strategy for its realisation.

To achieve this transformative agenda, we need to increase the capacity of the HIFA Secretariat. HIFA has just one professional staff and a part-time administrator supporting a network of hundreds of volunteers. During 2025-2027 we aim to engage a second professional staff member.
